Waiver and Release of Liability:

THIS AGREEMENT is entered into by and between Chewie's Playland, LLC (the "Daycare") and ("Owner"). Please initial each statement.

1) I, _____, hereby certify that I own the above pets listed and the information is correct to my knowledge. I have also acknowledged that I need to provide proof of vaccinations and fecal test from my veterinarian to Chewie's Playland when asked or my pet(s) may not be allowed to board or participate in doggie daycare. _____(Initial)

2) I also hereby certify that my pet(s): is/are in good health or if they currently have medical conditions they are being treated by a veterinarian and the veterinarian has cleared them for boarding or doggie daycare. I further certify that my pet(s) has/have not shown aggressive or threatening behavior towards any person or any other animals unless otherwise stated. I further certify that my pet has not bitten any person or any other animal, unless otherwise stated. _____(Initial)

3) I will continue to provide proof of updated Rabies, Distemper combo, and kennel cough vaccinations as well as yearly negative fecal results when they have expired on my pet(s). I understand that I will need update my pet(s) health history once a year and I understand that if any health related concerns arise I will notify Chewie's Playland. _____(Initial)

4) I understand that my pet(s) will be isolated and suspended from day care if he/she shows signs of illness such as coughing, sneezing, vomiting or diarrhea and will not be allowed to attend day care until they have been well for 3t 7 days depending on the case or I provide proof from a veterinarian that they can participate in boarding or day care again. _____(Initial)

5) Chewie's takes serious measures to make sure we minimize all risks of communicable diseases that I understand that by participating in boarding or daycare that my pet(s) is more at risk for upper respiratory viruses, GI viruses or interstitial parasites. I do not hold Chewie's responsible if my pet(s) becomes ill. _____(Initial)

6) I understand that my dog(s) will be isolated or suspended from day care if he/she shows any aggressive or threatening behavior towards any person or any other dog. I also understand that my dog may be suspended from doggie day care for any poor behavior that includes, aggression, destructive behavior, continual barking etc. They may resume doggie day care once this behavior is corrected. (We are also willing to help the owners with this behavior). _____(Initial)

7) I understand and agree that during normal dog play, dogs may sustain injuries and I am responsible if treatment is needed. All dog play is monitored by staff to avoid injury, but scratches, punctures, torn ligaments, and other injuries may occur despite the best supervision. _____(Initial)

8) I further understand and agree that any behavioral or physical health problems that develop with the pets while at Chewie's will be handled and treated as deemed best by the employees, staff and volunteers of Chewie's, in their sole discretion, and I expressly agree to assume full financial responsibility for any and all expenses arising or relating thereto. This includes aggressive or destructive behavior. _____(Initial)

9) I understand that Chewie's takes extra precautions by using a martingale non slip collar when walking the dogs or letting them play in the outside fenced in area. I agree to assume full liability if my dog(s) escapes and will not hold Chewie's Liable. I understand if I sign my dog up for fieldtrips that the fieldtrips are partially off leash, by signing my dog up I am stating they are off leash trained and do not hold Chewie's responsible if my pet escapes _____(Initial)

10) I understand and agree that it is my responsibility to leave an adequate supply of food and medications for my pet(s) during their stay at Chewie's. Should the food/medication supply need replacement, I authorize Chewie's to purchase replacement and will reimburse Chewie's for cost of the food and medication plus a \$25.00 replacement fee (per occurrence) plus the actual food and medication costs. Should a dog be observed to have fleas or ticks while attending daycare, a treatment will be applied and charged to the owner at a minimum rate of \$20.00.

11) Our caring and trained staff is happy to provide care for extremely old, chronically ill or otherwise debilitated pets requires extra care, which However, special needs pets, puppies and senior pets naturally have a higher risk of injury, stress related illness, or exacerbation of any pre-existing condition. As such, by having your special needs pet, puppy or senior pet with us you are waiving any claim for injury or illness experienced by your pet while in our care and that is not directly caused by the negligence or lack of care on the part of our staff.

12) I also understand that in case of an emergency and I am unable to be reached, If any behavioral or physical health problems that develop while my pet is at Chewie's will be handled and treated as deemed best by the Chewie's staff. We will do what is in the best interest of th pet(s) to stabilize them or medically treat with in reason. I am aware that I will be fully responsible of all charges that will be occurred. _____ (Initial)

13) I understand and agree that if my pet(s) is/are not picked up by the end of the Chewie's regular business day, then I hereby expressly authorizes Chewie's to take my pets in to after hours care and promises to pay Chewie's all costs of continuing such care. Further, I understand that if I do not pick up my dog(s) as scheduled, Chewie's will be authorized to proceed according to the local municipal code governing abandonment of animals.

14) I understand that pre-paid packages are nonrefundable and expire 12 months from the date of purchase. Fees are due and payable at the end of each day. Payment may be made by cash, credit card or approved checked. Discounted packages are provided only if they are paid for in advance. Our program is flexible enough to accommodate reasonable special needs requests. _____ (Initial)

15) I understand that when booking a boarding that there is a cancellation fee if not canceled within Chewie's policy. I also understand that if I do not give 24 hours notice when canceling daycare a fee or pass maybe used.

Acceptance of Risk and Release of Liability Form

To be signed in addition to a completed Chewie's Application form

At Chewie's we are committed to providing the best services, play areas and activities in a safe environment. We hold the safety of Chewie's Playland Indoor Dog Play Park and Agility as a priority with the safety of the dogs, clients and persons in the highest regard. **Please read all paragraphs and initial after and sign at the end.**

Chewie's Playland strives to have the best safety measures in place to reduce risk and insists that all persons using the Indoor Play Park has fully completed all parts of our main application and understands our policies. Persons who choose to enter Chewie's Playland "Indoor Play Park/Agility" must understand there are inherent risks of injury and damage associated with dog play. This can occur either during their individual time or open play time. Our indoor play park and Chewie's Playland LLC nor it's affiliate's (Chewie's Playland North, Chewie's Playland South, The Unconditional Canine at Chewie's Playland) are not responsible for any risk or damages as stated above. _____

During private rental periods with owners, there will be an daycare attendant on site but not in the room with you at all times. We will have a daycare attendant there during open play times but as the owner, you are responsible for determining if your dog is appropriate for off leash play if they have not attended daycare regularly. If the daycare attendant immediately notices any issues, you will be refunded and a note will be made that the dogs do not get along with each other so they are not scheduled for open play again together or an evaluation may be needed(this will be first come first serve). You understand the risk of being there with your dog and that injury may include other dogs and owners/staff. _____

We do not allow dogs with tendencies that put them at higher risk for injury or that may cause injury, for example, excessive barking, humping, biting/aggressive dogs, etc, whether aggressive to people or dogs in "Open Play". Chewie's Playland and our training service The Unconditional Canine at Chewie's reserves the right to determine if a dog is at high risk and can only rent time alone in the Indoor Play Park and you respect understand our decisions and recommendations. _____

Health Requirements:

As per our main application all dogs have to be up to date for Rabies, Distemper Combo(Or Acceptable titer), negative fecal check with Giardia, Bordetella(Or Waiver signed) and use flea/tick preventive and Heartworm. Preventive. If your pet requires an updated vaccination for the first time(i.e. not a booster), please make arrangements for the vaccination to be administered no less than 10 days before your visit to Chewie's. If you have newly rescued your dog we do need a fecal check with the vet that includes giardia and they also need to be past the 10 day isolation period. _____

PAYMENT POLICY

Pre-Payment is due at time of service/Check in. We can also keep your card on file if you would like. _____

REFUND POLICY

If you are asked to leave our Indoor Play Park for any reason any time after 15 mins or if you need to leave of park before the full time rented a refund will not be issued. _____

Warning of Risk

Chewie's "Indoor Dog Play Park/Agility" is intended to be an outlet for dogs and their owners to exercise, bond, and to work on training. Despite all warnings, rules and precautions, certain dangers still exist. It is nearly impossible to predict all possible situations that could occur. We strongly recommend training for proper agility equipment use or have had agility training to reduce the risk of injury when using the equipment and understand that you do not hold Chewie's Playland LLC is not liable for any injury that may occur using the equipment/tools/toys. _____

Risk can include minor or serious injuries and potentially death to both humans and dogs, as well as damage to personal property, arising out of improper handling, supervision, or lack of control of a dog. Children are especially prone to serious injuries such as bites, nips, scratches since they sometimes demonstrate behavior that may seem threatening or prey like to dogs. For example, yelling, screaming, quick movements, falling, and direct approaches to a dog can initiate a bite or attack, especially if the dog is unknown to the child. You as a parent/legal guardian are knowingly taking the above risks and will not hold Chewie's Playland or its affiliates liable _____

For safety purposes minors must be 13 years of age or older to enter Chewie's Indoor Play Park/Agility during open play times, it must be recognized that it is impossible for Chewie's Playland LLC to guarantee the safety of clients, their guests/children, and dogs. Minors of all ages can attend private sessions. Each person who enters our indoor play does so at his/her own risk and assumes the danger of using the play area. Those must understand that the equipment is not for person/children use and will be dismissed if seen. _____

Waiver and Release of all Claims and Assumption of Risk:

This agreement should be carefully read and be aware that entering the indoor play park you will be expressly assuming the risk of injury, illness or death to yourself, your children, and your dogs. As well as injury and damage to your property/dog because of your choice to use of the park, and that you will be assuming legal liability to others for any injury, death, damage to their property they suffer as a result of your use of the park. Agreement to Waiver and Release of all Claims and Assumption of Risk

Rules:

- 1) Please have your dogs go to the bathroom prior to entering the indoor play area.
- 2) Please clean any accidents with the appropriate labeled cleaner.
 - a. All solid accidents can be pick up with the provided bags, then please wipe area clean with Lysol wipe. Dispose of waste in the appropriate bin.
 - b. Urine accidents can be cleaned with a rag and our yellow marked cleaning bottles. We also have wireless carpet cleaner to help suck up any other liquids. If you need help using it please let a staff member know.
- 3) Wear and Tear is expected however if you dog causes major damage, you may be partially charged to repair or replace.
- 4) All toys and equipment should be put back in their areas.
- 5) If you do no not clean up after your pets accidents or marking the of equipment there is a \$50 cleaning charge, if it happens 3 times, you will be suspended from renting the indoor play park and agility equipment.
- 6) If the toys are ruined please bring attention to the staff so they can get you new ones, and the older ones discarded.
